NOTIFICATION

In view of the inauguration of the newly constructed facility for the Digital NI Act Courts at Rouse Avenue Court Complex and for optimal utilization of available infrastructure and resources, all the existing Digital NI Act Courts shall function from the said premises w.e.f. 31.05.2025.
