Sub.: Regarding disposal of condemned electronic / computer hardware items.

Sir,

This Court intends to dispose of the condemned electronic/computer hardware items (list attached at **Annexure-'A'**) as per e-waste guidelines. The authorized agencies registered with Delhi Pollution Control Committee (DPCC) or any other State Pollution Control Board(s) may send their authorized representative along with copy of Registration Certificate and authority letter to inspect the electronic/computer hardware items declared condemned, on or before **24/11/2025** on any working day between 11:30 AM to 03:30 PM. No representative shall be allowed- inspection without authority letter and copy of respective Registration Certificate. The authorized agencies may submit their quotation in a sealed envelope super scribing thereon "Quotation for condemned electronic/computer hardware items" addressed to The Registrar General, Delhi High Court, New Delhi and reach the Admn. Officer (J)(IT), Room No.6, Ground Floor, Lawyer Chamber Block-III, Delhi High Court, New Delhi - 110003 on or before **26/11/2025** (by 05:00 PM). The rates offered must be valid for four months from the last date of quotation. In case of increase or decrease in the condemned items, the rates may proportionately increase or decrease.

The selected (highest eligible) bidder is required to submit in writing that the firm fulfills all the e-waste Rules and produce Original Certificate for verification. The firm is also required to completely erase the data from the hard-disks of laptops/desktops before lifting the same from this Court.

This Court reserves the Right to accept or reject any or all the quotations without assigning any reason whatsoever and no correspondence will be entertained in this regard. No quotations shall be entertained after due date. Envelopes without subject shall be summarily rejected.

This Court reserves the right to modify/amend the quotation letter/Terms and Conditions at a later stage.

You are requested to take the necessary action at the earliest on priority basis.
